THE ORGANIZATION PROVIDED A 12 BED EMERGENCY SHELTER FOR RUNAWAY AND HOMELESS YOUTH (AGES 11 TO 18). APPROXIMATELY 82 YOUTH WERE SERVED IN 2013. ADDITIONALLY, THE ORGANIZATION COUNSELED 43 NON-RESIDENTIAL YOUTH AND 47 NON-RESIDENTIAL FAMILIES, AND HAD 59 PARTICIPANTS IN THEIR PARENTING SUPPORT GROUP.

IN 2013 THE ORGANIZATION STARTED A STREET OUTREACH PROGRAM. THE PRIMARY GOAL OF THE PROGRAM IS TO PREVENT THE SEXUAL ABUSE OR EXPLOITATION OF YOUNG PEOPLE LIVING ON THE STREETS OR IN UNSTABLE HOUSING BY MOVING THEM TOWARD STABLE LIVING SITUATIONS. THIS IS DONE BY REACHING OUT TO THEM TO PROVIDE THEM WITH THE SUPPORTIVE NETWORKS THAT ARE AVAILABLE IN OUR AREA. THIS
